We will send an email notice to the student's @vanguard.edu email account when verification is complete. Submit all documentation with appropriate signatures and attachments through MyVU Financial Aid Self-Service Portal by **June 1, 2021** to receive your financial award letter in early summer before financial registration and payment plan deadlines.

A. HIGH SCHOOL COMPLETION STATUS

You must submit documentation of high school completion or an equivalent. Check the box of the document you will attach to this worksheet:

- High school diploma or high school transcript including graduation date
- Official documentation from high school counselor stating your graduation date and reason why high school diploma/transcript is unavailable
- General Education Development (GED) Certificate
- State certificate stating you have passed a State-authorized examination recognized as an equivalent of a high school diploma
- Academic transcript of a successfully completed two-year program (60 units) acceptable for transfer for full credit toward a bachelor's degree
- Homeschool student: 1) a transcript or equivalent signed by parent/guardian or program official listing secondary courses you have completed and documentation that you have successfully completed secondary school education; or 2) a secondary school completion credential provided under State law
- If you do not have documentation that meets any of the above requirements and are seeking an associate degree or its equivalent and excelled academically in high school, you may provide documentation from the high school stating that you excelled academically in high school and documentation from your current/future postsecondary institution that you have met their formalized written policies of admission

B. DOCUMENTATION OF IDENTITY/STATEMENT OF EDUCATIONAL PURPOSE

In order to complete the verification process, you will need to appear in-person at the Financial Aid Office and present a government- issued ID (driver's license, military ID, passport, etc.) and this verification worksheet to an authorized Financial Aid Office staff member, who will need to validate the statement below at the time of submission by providing a signature and date. ***If you cannot appear in person to submit this worksheet, you will need to provide a copy of your government issued ID and this worksheet notarized by a public notary.***
