## ANTI-HUMAN TRAFFICKING CERTIFICATE REQUIREMENTS (12 UNITS)

Develop new skills and build expertise in the area of human trafficking to update your professional profile, broaden your knowledge base, and keep up with changes in your field. The Anti-Human Trafficking Certificate is designed to provide a comprehensive overview of anti-trafficking efforts aligned with best practice models.

### COURSES

#### **HUMAN TRAFFICKING (WMST 345) – 3 UNITS**

This course will give an introductory overview of contemporary human trafficking and slavery, including sex trafficking, bonded labor, forced labor, child soldiers, and domestic servant slavery.

#### **COMMERCIAL SEXUAL EXPLOITATION OF CHILDREN (WMST 430) – 3 UNITS**

While discussing the theories of child development, early childhood trauma, and the stages of change, a key of the CSEC curriculum will be to identify strategies for early intervention with at-risk and vulnerable youth.

#### **AFTERCARE FOR VICTIMS OF HUMAN TRAFFICKING (WMST 435) – 3 UNITS**

In light of best practices, this course seeks to equip students with the knowledge needed to understand the holistic needs of human trafficking survivors as they begin their aftercare and restoration process.

#### **HUMAN TRAFFICKING AND ETHICS (WMST 440) – 3 UNITS**

Students will investigate the responsibility of business, consumers and media through the lens of a biblical ethics framework related to Human Dignity and Purpose in relation to trafficking.

#### **LABOR TRAFFICKING (WMST 470) – 3 UNITS**

Students will investigate the domestic and international scope of the problem, how it relates to sex trafficking, how supply chains can reveal labor exploitation, and how collaborations can stop labor trafficking practices.

This Certificate will establish a baseline of knowledge for professionals and students from many disciplines. The literature supports a best practice multi-disciplinary team approach to all aspects of anti-human trafficking. For professionals, earning this certificate will provide a strong foundation to bring existing expertise to the table in ways that expand our community and value your unique contribution. Completing the certificate demonstrates commitment and clear knowledge base. We believe that it will validate your achievement and improve your opportunities for advancement.
